
## REPORT SUBMITTED BY THE CHAIRMAN OF THE EXPERT COMMITTEE

### Strength

- Faculty is qualified sufficient in number and well motivated.
- Teaching learning process is effective, course files are well maintained, sessional evaluation is good.
- Academic calendar is followed, projects are monitored and well executed.
- Lab space is adequate and practicals are well conducted, regularly evaluated.
- Lectures by Industry professionals are arranged for coverage beyond syllabus

### Weakness

- Sports, cultural activities, personality development programmes needs to be regularly, properly organized.
- Canteen, hostel mess needs serious and immediate attention for drastic improvement, hygiene is poor, toilets, drinking water facilities to be provided on every floor, common room for girls, boys needed.
- All faculty are not paid proper/actual AICTE scales. Some are paid consolidated, DA/HRA not paid as per rules.
- Results, placement needs lot of improvement. Industry-interaction should be strengthened.
